2. **Right to Refuse Service** – Auto Sense for Gals Ltd reserves the right to refuse or cancel any advertising in its sole discretion and without limitation if it considers that the Advertiser has breached any terms of the contract, the ad copy and/or content provided is harmful or indecent, may be legally actionable or violates the intellectual property of third parties.
3. **Advertising Content** – The Advertiser agrees to provide Auto Sense for Gals with the content required for the preparation of the advertising copy and shall review and approve all advertisements in due time prior to release. The Advertiser further agrees that the advertising copy represents and warrants that the content for all advertisement supplied to Auto Sense for Gals will be true and correct, does not infringe any third party's copyright, trademark or other intellectual property rights, is not misleading, harmful or false advertising and does not violate any provincial, federal or governmental laws and regulations.
4. **Services payment and default** – the 'advertiser' agrees to pay the fees upfront at the time the contract is signed.

8. **General Disclaimers** – to the maximum extent permitted by the law, Auto Sense for Gals disclaims any obligations and warranties, expressed or implied, that are not expressly set forth in this agreement, including without limitation: a) Auto Sense for Gals does not warrant the number of responses to the Advertiser's advertisement, the number of web site visitors who will view the Advertiser's advertisements; b) Auto Sense for Gals does not warrant that the internet services will be uninterrupted or error free.
